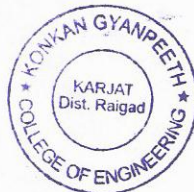
6. **Safety and Security norms:**

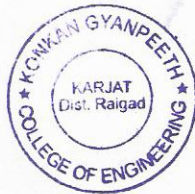
12. Arbitration

In the event of the arbitrator to whom the matter is originally referred vacating his office or being unable to act for any reason the CMD as aforesaid at the time of such vacation of Office or inability to act, shall designate another person as above to act as arbitrator. In accordance with the terms of the agreement such person shall be entitled to proceed with the reference from the point at which it was left by his predecessor. It is also a term of this contract that no person other than the CMD or a person nominated by such CMD of the RCF as aforesaid shall act as arbitrator hereunder. The cost of arbitration shall be shared equally by the parties. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to the agreement, subject to the provisions of the Arbitration and Conciliation act, 1996 or any statutory modification of or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause. The Arbitration shall be held at Mumbai and conducted in English language.

13. Force Majeure

Neither party will be liable to the other for non-performance of this Memorandum or any part thereof due to Force Majeure conditions. 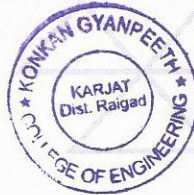
